About Our Program

The Lancaster Rec Before and After School Care program provides state-certified child care for children whose parents are working or are in training. Our goal is to provide an enriching, safe environment for children to participate in funfilled learning activities which promote creativity, social skills and independence, while receiving quality care by a caring and nurturing staff.

Our Before and After School Care program staff plans and conducts activities and lessons to support each child's development and learning. The goals of our activity-based curriculum are to help children meet state standards in academic areas, reinforce classroom learning, improve social and communication skills and help children be more physically active. Children play outdoors (weather permitting), make craft projects and get help with homework.

Children in Grade K5 through Grade 5 are welcome. Children in Grade 6 and Grade 7 at Elizabeth R. Martin may also attend. Only students who attend School District of Lancaster elementary schools are eligible to attend our programs.



The Benefits

Your Child's Progress

- Developmental assessments from observations are completed twice a year and are reviewed with you during conferences to update you on your child's progress.
- To help involve families in their children's learning and development, Family Night is held two times a year. Family Night includes an educational program, a time to meet other children and their parents/guardians, food and fun for the whole family.

Before School Program - 6:30 a.m. to start of school day

• We supervise breakfast provided by the School District or you may provide breakfast.

After School Program - end of school day to 6 p.m. (Second Wednesday of each month 12:30-6 p.m.)

• Each child gets a light snack and fruit juice or milk to drink.

All-Day Camps - 7 a.m.-6 p.m.

 All-Day Camps are held at your child's school and the Lancaster Rec Center. Make sure you check our Calendar and Fees Schedule for specific days. There is no All-Day Camp on Labor Day, Thanksgiving Day, the Friday after Thanksgiving, Christmas Eve, New Year's Eve and Memorial Day.

Registering for Before & After School Care

All Before & After School Care registration is now online! Scan the QR code below to register today. If you do not have access to a computer or smart phone, stop by the Lancaster Rec Center and we will help you get registered. Your spot is reserved once you receive a payment confirmation email from Lancaster Rec.

An annual non-refundable registration fee of \$70 (plus \$10 for each additional child from the same family) is due at the time of registration and at the beginning of every new school year.

Children are not permitted to attend Before & After School Care programs until all items have been turned it. All forms are included in the online registration packet, but you will need to upload the following:

- Completed and signed Health Appraisal Form (Physical) and Immunization (Shot) Records
 - Physicals and Shot Records less than one year old are required.

Please Note: printed registration forms will no longer be accepted. ALL registration must be done online.
